- b) Name of fund may be completed suitably.
- c) Definition of term "Family" as given in the General Provident Fund (Central Services) Rules, 1960 is reproduced below:-

## **FAMILY MEANS:**

- i) In the case of a male subscriber, the wife or wives and children of a subscriber and the widow or widows, and children of a deceased son of the subscriber, provided if a subscriber proves that his wife has been judicially separated from him or has ceased under the customary law of the community to which she belongs to be entitled to maintenance she shall henceforth be deemed to be no longer a manner of the subscriber's family in matters to which these rules relate, unless the subscriber subsequently intimates in writing to the Accounts officer that she continue to be so regarded,
- ii) In the case of a female subscriber, the husband and children of a subscriber, and the widow or widows and children of a deceased son of a subscriber provided that if a subscriber by notice in writing to the Accounts officer expresses her desire to exclude her husband from her family, the husband henceforth be dammed to be no longer a member of the subscriber's family in matters to which these rules relate, unless the subscriber subsequently cancels such notice in writing.

Note:- Child means legitimate child and includes an adopted child where adoption is recognized by the personal law governing the subscriber.

- (d) Col.4 If only one person is nominated the words "in full" should be written against the nominee. If more than one person is nominated, the share payable against each nominee over the whole amount of the Provident Fund shall be specified.
- (e) Col.5 Death of nominee(s) should not be mentioned as contingency in this column.
- (f) Col 6 Do not mention your name.
- (g) Draw line across the blank space below last entry to prevent insertion of any name after you have signed.

Note:- A nomination shall become invalid in case of subscriber who had no family at time of nomination subsequently acquiring a family.
